THE NINE CONDITIONS - "THE REORGANIZATION WILL..."

- · Be adecuate in terms of number of pupils
- · Be organized on the basis of substantial community identity
- · Result in an equitable division of property and facilities
- · Preserve ability to educate; not promote racial/ethnic discrimination/segregation
- · Not increase costs to the state
- · Promote sound educational performance; not significantly disrupt programs
- · Increase in school facility costs will be insignificant and incidental
- Be primarily designed for purposes other than increasing property values · Promote sound fiscal management or cause a substantial negative fiscal effect

OVERVIEW

- In the fail of 2007, the governing boards of the Menifee Union School District and the Perris Union High School District passed resolutions supporting the petition for the unification of the Menifee Union School District.
- In the spring of 2008, the Riverside County Committee on School District Organization held a public hearing on the petition and subsequently reviewed said petition to determine if the nine conditions detailed in Galifornia Education Code 35753(a) had been substantially mot.
- In May, 2006, the County Committee determined that five of the nine conditions had not been met. The petition and the Committee's recommendation was then forwarded to the California State Board of Education for its consideration.
- In the fall of 2009, the respective governing hoards requested the State Board of Education hold in abeyance the petition for unification.

WHAT'S NEXT?

- The next steps are at the complete discretion of the governing boards of the school districts involved. · React
